For Your information: Membership in WODL is available to an amateur theatre group which has been in operation for a period of at least one year, has a board of directors and has presented at least two plays. Annual Member Fees of \$200.00 are payable by the 1st of October of the current fiscal year. Members wishing to participate in our Annual Festival should apply for Adjudication with a fee of \$150.00 before September 30th

Membership fees are due with the application form. You must be a member group before applying for adjudications. Once your application form for membership has been received and reviewed, you will receive a notification pertaining to acceptance or denial. Part of the review will include a meeting with your board of directors by the Membership Chair and a representative of the WODL board.

Your Group should have two representatives for WODL meetings that are held twice a year. Once in October and once in February.

These meetings are informative and educational.

Also very important is WODL's Annual General Meeting which is held in July on the weekend of Minifest.
